Programs that will not accept the students whose first nationality is Turkish and/or students with blue cards will enter the relevant quota as "0". The quota proposal table must be filled out and sent to the Department of Student Affairs in the Annex to the decision of the Faculty Board for inclusion in the Senate agenda. If quotas are not filled in the final enrollment, quotas can be transferred between programs on a Faculty/Unit basis in accordance with the decision of the Faculty Board. ADMISSION OF INTERNATIONAL STUDENTS TO UNDERGRADUATE PROGRAMS

Application Conditions:

1) Candidates must be in the last year of their secondary education (high school) or have to be graduated.

2) **The following candidates can apply for international student status.**

Applications of international students will be accepted on the condition that they meet the following conditions:

a) Citizens Of Foreign Countries.

b) Those who are Turkish citizens by birth but who have been granted permission to renounce Turkish citizenship from the Ministry of Internal Affairs, and their minor children who are registered in the certificate of renunciation of Turkish citizenship, certify that they have a document regarding the Exercise of the Recognized Rights received in accordance with the Turkish Citizenship Law. (7th article of the Turkish Citizenship Law No. 5901. says that "(1) " A child born in the Union of marriage to a Turkish citizen mother or father in or outside Turkey is a Turkish citizen." and it is useful for candidates who will apply for admission quotas from abroad should examine the Turkish Citizenship Law.)

c) Those who have dual nationalities as they become Turkish citizens later.

ç) Those who have completed the last three years of their secondary education (high school) in a foreign country other than TRNC if they are those who are Turkish national and continue their education abroad before the date of 01/02/2013. (Including those who have completed their entire secondary education (high school) in Turkish schools in a foreign country other than TRNC, which have been opened by the Ministry of Education)

d) Those who have started their secondary education (high school) in a foreign country other than TRNC after the date of 01/02/2013. (Including those who have completed their entire secondary education (high school) in Turkish schools in a foreign country other than TRNC, which have been opened by the Ministry of Education)

e) A TRNC national who lives in the TRNC and has completed secondary education (high school) in the TRNC

f) TRNC students who enrolled in colleges and high schools in other countries and have or will have GCE AL exam results between the dates of 2005-2010.

3) **Applications of the candidates with the following conditions will not be accepted.**

a) Those who are Turkish nationals and completed their whole secondary education (high school) in Turkey or TRNC.

b) TRNC citizens. (Excluding those who have completed their entire secondary education (high school) in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling and studying at colleges and high schools in other countries between 2005-2010)

c) Those whose first nationality is Turkish by birth with dual nationality as defined in subparagraph (b) of the second paragraph. (Excluding those who meet the conditions in subparagraph (ç) and (d) of the second paragraph).

ç) Those with dual nationalities and one of them is TRNC nationality. (Excluding those who have completed their entire secondary education (high school) in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling and studying at colleges and high schools in other countries between 2005-2010)

d) Turkish nationals who have studied at the schools located within the embassies in Turkey and the foreign schools located in Turkey or those whose first nationality is Turkish by birth with dual nationality as defined in subparagraph (b) of the second paragraph.

Applications:

1) Application requirements and calendar, along with the application guide, are announced on the ASBU website following the approval of the Senate. The candidates can apply for the programs they want to study online on the Social Sciences University of Ankara International Student Application page. Online applications made on <https://isoafis.asbu.edu.tr/> web page are received in accordance with the application calendar and pre-evaluation of online applications is made through the International Office. Applications that are the basis of evaluation are sent to ASBU International Student Admission Commission to be finalized.

Base Scores for Application:

For the admission of international students to our University, **International Exams, Local Exams and the base scores of diplomas taking place in the Examination and/or Diploma list valid for the Admission of Undergraduate Students from Abroad to Social Sciences University of Ankara determined by the University Senate and they are valid for the relevant year. (See-Annex-1)** There is no limit on the validity period of exams that have the status of high school graduation exams, but the validity period of exams that have the status of a university entrance exam is two years.

Evaluation of the Applications:

1) ASBU International Student Admission Commission makes an assessment within the quota, starting from the scores obtained from the international exams requested by the Senate. These exams and country-specific scores are evaluated according to the "ASBU examination and/or diploma list valid for admission of undergraduate students from abroad " which is determined by the Senate. In addition, the national exam scores made by other countries and the General YÖS Exam scores made by the institutions accepted by the University Senate are considered as priority. Student admissions can also be made according to the secondary education success score. YÖS exam score and secondary education achievement score acceptance limit and / or rate are determined by the Senate and announced in the Exam and / or Diploma List Valid for Undergraduate Students from Abroad of Social Sciences University of Ankara.

Applications of candidates who do not meet the application requirements will not be evaluated. Having met the application conditions does not qualify the candidate for placement.

2) The evaluation of the applications and the announcement of the final result are completed by the relevant International student admissions commission. The announcement and notification of the results to the candidates are made by the International office.

3) The list of students who are entitled to register is finalized with **the decision of the University Executive Board.**

Announcement Of Results:

- 1) Application results are announced on the website of the Registrar's Office and the International Office.
- 2) An "Acceptance Letter" is issued by the International Office for candidates who have the right to register to the university. The exact registration dates of international students who are eligible for registration take place in the Acceptance Letter. Registrations are made by the Registrar's Office. **Candidates must come in person to registration.** In cases where they have excuses, they can be registered by their legal or voluntary (power of attorney issued in the presence of a notary) representative. **Registration cannot be made on the internet or by mail.**

Tuition Fee:

- 1) The amount of tuition fees to be received from international undergraduate students who are entitled to study at our University is **6000 TL** for the year of 2021 in accordance with the conditions determined for the relevant year by the Decision on the Implementation of the Presidential Decree on the Determination of Tuition Fees. In accordance with the first paragraph of Article 9 of the Decision Regarding the Determination of Tuition Fees and Contribution Shares to be Taken as Student Contribution to Current Service Costs in Higher Education Institutions in the 2020-2021 Academic Year (Decision No: 1842), the tuition fee for the Turkish Language Literature Program for 2021 is **4000TL**. **If the student who has obtained the right to register and has registered requests that his / her registration be deleted, the deposit fee will not be refunded.**
- 2) Tuition fee is not taken from the students who have an official Republic of Turkey ID card. The amount of contribution fees to be taken as Student Contribution to Current Service Costs of Higher Education Institutions of **students with Blue cards** and the amount of contribution determined in the Decision on the Implementation of the Presidential Decree on the Determination of Tuition Fees are covered by **the Presidency for Turks Abroad and Related Communities**. The tuition fees of **the international students who are eligible to register through the International Theology program under the Coordination of Turkish Religious Foundation** are also covered by the **Turkish Religious Foundation** in accordance with the amounts of contributions determined in the relevant Presidential decision.

Registration:

- 1) Registrations are made by the Registrar's Office on the dates stated by the academic calendar, according to the evaluation results of the ASBU International Student Admission Commission.
- 2) **Documents required for final registration;**
 - a) Registration Form
 - b) Original High School Diploma and Diploma Equivalence Certificate (A Turkish Copy approved by the T.R. Embassy or Consulate)
 - c) Foreign Language Proficiency Certificate, if any
 - ç) Turkish Proficiency Certificate, if any
 - d) Certified Student Visa to be taken from Foreign Representatives or Turkish sample of the visa certified by the Turkish Republic Embassy or Consulate

- e) Certified passport or ID card to be taken from official authorities or Turkish sample of the ID card certified by the Turkish Republic Embassy or Consulate
- f) Bank receipt showing that the contribution has been paid
- g) Biometric Photo (4 pcs.)
- h) An official or notarized document or letter of undertaking that the candidates have an income above the amount that can ensure that they can continue their education at the university. (The foreign students who will continue their education at our university should document that their financial situation is appropriate for their education with a certificate taken from the administrative units of their country or their consulate in Turkey)
- i) For the Turkish citizens, T.R. ID no statement or photocopy of their ID card
- i) A document approved by the official authorities regarding the military service status of male candidates of Turkish nationality.
- j) The original copy of the GCE AL exam result document of the TRNC nationals who have completed their entire secondary education in TRNC high schools.
- k) A copy of residence permit (Foreign candidates who are obliged to apply to the police authorities and obtain a residence permit after registration must submit a copy of their residence permit.)

Documents Requested By The Provincial Migration Administration:

Since the residence permit applications will be taken by our university as of 2017, these documents must be prepared during registration and submitted to the provincial immigration administration by **the student in person.**

- a) Student Residence permit application form (When the application is completed through the e-ikamet system (e-residence system), it is created by the system; the application form is printed and signed)
- b) Original and photocopy of the documents replacing the passport or passport (you must have a passport or document replacing the passport for 60 days longer than the requested permission period)
- c) Photograph (taken in the last six months, the fund should be white, biometric, 4 pcs.)
- ç) Valid health insurance, e) a declaration that they have sufficient and regular financial opportunities during the stay (It is declared in the application, but the unit may request a supporting document)
- d) A valid and correct address statement (e-signed/ signed if they are staying at the dormitory)/ sealed / stamped dormitory certificate or notarized rental agreement,
- e) Foreign Student Information Form (will be given by our university after registration)

Language Of Education:

1) Students enrolled in programs whose the language of instruction is English are subject to **the provisions of the Education and Examination Regulation of Social Sciences University of Ankara Foreign Languages Preparatory Program.**

2) **International students must document their Turkish language proficiency** in order to enroll in **undergraduate programs of which language of instruction is Turkish.** For foreign students who have graduated from a secondary education institution in Turkey by being educated for at least three

years, the Turkish language requirement is not required. In order for the candidates to start their undergraduate education, they must have a Certificate of Turkish proficiency at the level of C1 from the Turkish proficiency exams such as ASBÜ TÖMER, TÖMER, DİLMER or TYS. Candidates who have completed all their secondary education in Turkish high schools affiliated to the Ministry of National Education are considered to have sufficient Turkish language.

3) In order to enroll in **undergraduate programs where the language of instruction is English**, international students must document their English language proficiency. Foreign language proficiency is not required for candidates who have graduated from programs in which the language of instruction is English or graduated from secondary education institutions in countries where English is spoken as a mother tongue or an official language, provided that they are at secondary education level at home or abroad. Candidates who have **sufficient scores from** any of the foreign language exams mentioned **in the table below** can start undergraduate programs.

4) In order to enroll in **the undergraduate programs of which language of instruction is a foreign language other than English**, international students must document the relevant foreign language proficiency. Foreign language proficiency requirement is not required for candidates who **graduate from programs in which medium of instruction is the relevant foreign language, or from secondary education institutions in countries where the relevant foreign language is spoken as a mother tongue or an official language, provided that they are at the secondary education level at home or abroad**. Candidates who have sufficient scores from any of the foreign language exams mentioned in the table above can start the undergraduate program.
